

## Update to the action station

To support the upcoming Companies House changes under ECCTA (effective **18th November**), the Action Station has been updated with new features:

### Confirmation Statements (CS01s)

- The Action Station will now flag when **Directors have not yet provided their UIDs** for pending CS01 filings.
