This will open a table with the following columns for each PSC:

- **Name** – The full name of the PSC.
- **UIDs Received?** – Indicates whether a UID (Unique Identifier) has been received.
- **ID Number** – Displays the UID if available
- **CS01 Due Date** – Shows the next confirmation statement due date.
- **Number of Companies** – How many companies the PSC is associated with.
- **Number of Roles** – The number of PSC roles they hold.
- **Status** – Indicates whether ID is required, with a dropdown menu that can be used to update the status.
- **Last Update?** – Shows the date of the most recent update.
- **By Whom?** – Displays the name of the team member who last made a change.

Additional Features:

- **Hover for Details** – Hover over the **Number of Companies** or **Number of Roles** values to view more detail, including company names, or PSC roles held by the person, and associated CS01 due dates.
- **Update Status** – You can update statuses directly from the table and save your changes.
- **Export** – Use the **Print & Export** button to download the table as needed.
- **Sort by CS01 Due Date** – The table can be sorted by confirmation statement deadlines to help prioritise actions.
- **Recalculate PSCs** – When there have been share changes or company deletions, you can click this button to refresh the list, so it always shows the current PSCs, this might take a bit of time if there are a lot of companies in the account
